Surety Bond

A three way agreement guaranteeing that a principal will carry out the contractual obligation the principal has agreed to perform or alternatively to compensate the other parties to the contract for losses resulting from the principal's failure to perform.

Fiduciary Bond

Bonds which guarantee an honest accounting and faithful performance of duties by administrators, trustees, guardians, executors, and other fiduciaries.
